**Charge of Ownership:**

1) Any owner of a Dangerous Dog who sells or otherwise transfers ownership, custody, or residence of the dog shall, within ten business days after such change of ownership or residence, provide written notification to the Office of Code Enforcement of the name, address and telephone number of the new owner. It also shall be the responsibility of the person transferring ownership or custody of the dog to provide written notification of the dog's classification as dangerous to the person receiving the dog. The previous owner shall furnish a copy of such notification to the Office of Code Enforcement along with written acknowledgement by the new owners of his receipt of such notification. The Director of Code Enforcement or his/her designee shall notify the Police Department of any changes of ownership, custody or residence of the dog within three business days after receiving the required information from the previous dog owner.

2) *Continuation of dangerous dog declaration.* Any dog that has been declared dangerous by any agency or department of this Town, another municipality, county, or state shall be subject to the provisions of this ordinance for the remainder of its life. The person owning or having custody of any dog designated as a Dangerous Dog by any municipality, county, or state government shall notify the Office of Code Enforcement of the dog's address and conditions of the maintenance within ten days of moving the animal into the Town of Lauderdale-By-The-Sea. The restrictions and conditions of maintenance of any dog declared dangerous by this Town, another municipality, county, or state shall remain in force while the dog remains in the Town.

**A photograph of the dog must be submitted with this application.**
